Q7. Are there any other comments you would wish to make that are relevant to this proposal?

Our LA introduced SDS option 1 as a free of charge until April 2015. Then people were informed they will have to contribute 55% of residual income (from a nil contribution). This has caused enormous upset for people.

LA also decided to pay net so people have to put contribution into package otherwise they cannot pay employees etc. This has caused some people to cancel their care as they cannot afford the contribution. The figures quoted in the tax taper rates and the hourly rates in the consultation appear to be incorrect for Scottish Borders Council.
